# TREASURER'S REPORT

• Tim Colburn notified the board of the bookkeeping transition from BHM to Bichard Group. Transition will happen at the end of January.

- 2022 Audit has been completed; the state should be releasing it at any time.
- Tim Colburn gave an overview of larger changes in the financials. Specifically, the Sofidel gas accounts for as well as the decrease in accounts receivable due to an error in billing for the CRA payments. These payments were written off in 2023 but will be collected over the next 15 years.
- \$25,000 Thriving Communities Grant from Norfolk Southern was discussed. The Logistics Careers Camp created from this grant will be hosted by P3 and Pickaway WORKS during the fall.
